

SAPC “Bundled,” Treatment, & Withdrawal Management Services

*Services highlighted in **YELLOW** should NOT be included in rate calculations because they either cannot be billed to DMC and must be reimbursed through non-DMC funds, are billed to FFS Medi-Cal, or were determined to be unnecessary codes for the respective service.
