For the Collaborative Spirit Award, can nominate one agency or multiple agencies that were instrumental in a specific collaborative effort or relationship

Process

- 1. Release nomination form Mar 7
- 2. Nomination forms due by Mar 21
 - Agencies can nominate other orgs, but not their own
 - Individuals can be nominated by colleagues within their own agency
- 3. 2 members of selection committee will review each application
- 4. Full selection committee meets to determine awardees
- 5. Awardees announced at May 2 All Treatment Provider Meeting

- ✓ PAC and PAC workgroup meetings are open to the public
- ✓ The new member application process will take place in Spring 2023
 - In June, half of the 22 members' terms expire
 - Bylaws allow for two consecutive terms
 - There must be at least a one-year pause before applying again after two serving consecutive terms
- ✓ After our new cohort is selected, we are due for a co-chair election
