Updated Insurance Requirement

County increased the minimum coverage amount for the Professional Liability component.

OLD Professional Liability \$2 Million NEW Professional Liability \$3 Million







Credentialing Process

- Based on the State of California, Department of Health Services, Mental Health Use Disorder Services (MSHUDS) Information Notice No: 18-019
- Will be incorporated into Sage Onboarding and Personnel Review during the annual monitoring audit
- Designed to leverage existing processes to streamline and minimize effort
- Initial and On-going
