CULTURAL AND LINGUISTIC COMPETENCE PLAN

This is permeates all aspects of our treatment system

- Patient, staff, community, workforce development, hiring, access, and treatment
- Can be heavy lift (CLAS, Title 42, part 438, and SAPC bulletin requirements)
- During FY 2018-2019:
 - 46% of provider sites had at least 1 staff either fluent or certified in a language other than English

54% of all direct service staff had completed any # hours CC training

Beginning early part of fiscal year 2019-2020:

- CIBHS will be providing individualized technical assistance to each provider
- Assist in activities related to the development & implementation of a CLCP
- Provide training to staff, assist in P&P, workflow development, etc.
- Providers to submit a CLCP by April 30, 2020

- Convey important information regarding treatment -
- Available for providers to use as orientation
- Play from any desktop, laptop, or tablet using link
- Approximately 8-10 minutes
- Provides a standardized way of sharing information

New SBAT Functionality Releases





Intake Appointment Calculator

- Helps maximize site workflow and staff planning
- Only visible on Provider Update site
- Uses information input by providers to calculate intake availability
- Automatically populates public-facing SBAT



Daily Zero Out Function

- Allows providers to update information daily
- Encourages real-time input
- Further assists CENS and SASH in identifying providers that are accepting new patients



Open Intake Appointment

- Public-facing SBAT
- User-friendly format
- Daily updates on open intake appointments helps:
 - o quantify intake appointments
 - o better understand site volume

SBAT Intake Slot Calculator

Do you know how many intakes your agency can perform?

The "SBAT Intake Slot Calculator" can help providers calculate the number of intakes that can be scheduled on a given day to maximize staff and organizational planning for the benefit of both treatment agencies and the patients they serve. Simply insert the information below, providing the number of staff you have available to work that day, the amount of time staff dedicated to intakes, the average intake time per client, and the number of intakes that were already scheduled for a given day. The calculator will calculate how many intakes you have available on a given day.
