Coming! Sage ProviderConnect Single Sign-on

Sage ProviderConnect Single Sign-on (SSO) is being tested for roll-out in September of this year.

Benefits:

- 1. Eliminates the need to log in again after completing the SAPC network multifactor authentication.
- 2. Helps to strengthen a system component affecting data reliability.

Date: Late September 2020

Will require an overnight downtime of ProviderConnect

Sage ProviderConnect SSO – What to Expect

- **1.** New log in instructions for Sage LIVE environment
 - a. URL will not change
 - b. Behind-the-scene changes to system will require users to refresh bookmarks
 - c. Users may need to update a browser setting if so, steps are well documented
 - d. Troubleshooting steps will be provided
 - What to do If you encounter issues logging in? Clearing browser cache is a key fix

2. Log out – 2 step process

- a. Log out of Sage ProviderConnect
- b. Select account to log out



To protect access to your Account, you MUST ensure to use this 2-step log-out process!

Sage ProviderConnect SSO Implementation Plan: What you need to know.

- 1. When: Please look for a Sage Communication specifically related to launch PCONN before the end of September 2020. Final date to be determined soon.
 - Please look for the special Sage Communication on PCONN SSO.
- 2. SAPC to send specific user (and SME) instructions on how to authenticate to Sage PCONN SSO.
 - This will include general troubleshooting measures on how to navigate this transition.
 - Users can also contact the Sage Help Desk for assistance at 855-346-2392.
- **3.** Preparation Webinar for your Tech Support or System Subject Matter Experts (SMEs).
 - SAPC will host a webinar specifically for provider agency IT experts and SMEs to aid them in assisting in their colleagues' transition to Sage PCONN SSO.
 - This will be held ~1 week before PCONN SSO Go Live.

RECOVERY SUPPORT SERVICES REMINDERS

COUNTY OF LOS ANGEL

To admit a patient into RSS, providers must follow the following steps:

- Discharge from the previous level of care in Cal-OMS discharge
- Admit into RSS on the Cal-OMS Admission
- Change Provider Diagnosis (ICD-10) form to reflect State approved remission diagnosis (See next slide)
- Submit authorization for RSS within 30 days of admitting into RSS.



Per MHSUDS Information Notice NO. 17-034:

"A beneficiary receiving recovery services will be in a state of "remission" due to the chronic nature of substance use disorders."

Group Billing Formula Updates



Current State

- Individual documentation time= 1 additional unit added to units/day per service.
 - I.e. 60 minutes counseling is 4 units plus 1 unit of doc= 5 units/day billed
 - Documentation time on note should reflect actual start and end times for documentation
- Group formula remains the same as with previous years
 - 15 minutes for 2-4 participants
 - 30 minutes for 5-8 participants
 - 45 minutes for 9-12 participants

Future State

- No changes to individual documentation time
 - 1 additional unit added to units/day per service.
- All billing will include service time, documentation time and travel time as appropriate.
- Group formula: Providers will be able to bill up to 10 minutes per participant for documentation time.
 - Each person in the group may have different times depending on the actual documentation time spent.
 - The per minute rate will be the same as the service rate on the rates and standards matrix for the level of care and staffing level.
 - I.e. \$2.18/minute for ASAM 1.0 registered counselor vs. \$2.62 for same group run by an LPHA





STATE DENIAL REMINDERS





State denials for Fiscal Year 18/19 and 19/20 were different than DMC-ODS' first year of billing.



The primary reasons for denials in FY 18/19 and 19/20 included issues with:

Patient related information

Provider related information

Performing Provider related information

Refers to creating a new claim for a service(s) that has already been denied.

Replacement Claim

Replacement claim is the correction or updating of a previously submitted claim. A replacement is sent when a data element on the original claim either needs to be added or needs to be corrected.

Payer Claim Control Number (PCCN)

This is the number assigned to each claim for tracking purposes and must be included on each replacement claim in order to follow the claim

Recoupment/Takeback

A claim is recouped or taken back after it has been denied by the State, which means money that has been paid out will be deducted from the next EOB posted in the system.



Billing with Sage

- Resubmit a new Claim
- This is the same process for any denied claim, local or state.
- State denied claims are voided in the Treatment History and original Bill Enum. As such, they will not show in the replacement claim drop-down.

Bill with 837P/I files

- Replace the service keeping the PCCN identifier provided by the SAPC on the 835 (REF*F8)
- CLM05-03 Must be '7' to indicate replacement claim and the PCCN from the 835 must be listed in REF02
- See SAPC's 837p Companion guide page 36 for example



Due to the hundreds of different code combinations, the crosswalk only includes the most common codes. In the event a provider receives a denial for a code that is not listed on the crosswalk, there are 2 options for how to decode the CARC/RARC combo:

- 1. Providers can go directly to the x12 website which is where codes are published to search for the language for the Claims Adjustment Reason Code (CARC) and the Remittance Advice Remark Codes (RARC). (Example: Denial CO 177 N424)

2. Use the existing codes on the crosswalk to form the combination needed.

- We included all the codes and exact verbiage from X12 in column B of the crosswalk. Most combinations can be found using the existing values in column B.
 - I.e. if you receive a denial for CO 177 N424
 - » Search for CO 177 which states "Patient has not met the required eligibility requirements. (177) "
 - » Then search for N424 which states "Patient does not reside in the geographic area required for this type of payment.(N424)"
 - » This may translate to the patient is not eligible due to not living within in LA county or having their medi-cal assigned to LA county.

Clarification of training requirements for registered SUD counselors who have completed their education but are not yet certified

- <u>Issue</u>: We have received several inquiries related to education requirements for Registered SUD Counselors who have completed their education but are not yet certified.
 - SAPC's most recent Provider Staffing Guidelines (IN 19-07) highlights training requirements for SUD counselors. Unfortunately, we discovered the language in the recently published Provider Manual 5.0 did not include the edits from IN 19-07.
- <u>Clarification</u>: Registered counselors who have completed their training but have not yet become certified will still be required to have 45 hours training annually. This training requirement can be completed either via additional coursework <u>or</u> CE approved continuing education. SAPC's clinical training sessions can meet this requirement.
- <u>Future steps</u>: SAPC will work to revise and release an updated Provider Staffing Guidelines IN to clearly indicate that this continued training can be completed via either by additional coursework or continuing education.
