SAPC Rates Matrix

SAPC is excited to share a DRAFT of DPH-SAPC's Substance Use Disorder Treatment (SUD) Reimbursement Rates for Fiscal Year (FY) 2023-2024 and a DRAFT Rates Matrix with its substance use disorder (SUD) network. The Rates Matrix has been released for public comment to allow provider agencies an opportunity to review and provide suggestions and/or comments prior to finalization and official release.

The SUD treatment reimbursement rates were designed to allow providers to make needed investments in SUD treatment services and to make the necessary investments to transition to value- and outcome-based care.

The DRAFT Rates Matrix also reflects the payment reform changes under the California Advancing and Innovating Medi-Cal (CalAIM) Initiative that will take effect on July 1, 2023.

These include the following:

- Practitioner-level rates for Outpatient and Intensive Outpatient services.
- Tiered rates based on a provider's DPH-SAPC-contracted and utilized levels of care (SAPC will notify agencies of their Tier).

Additionally, DPH-SAPC has incorporated many of the providers' design recommendations and input into the DRAFT Rates Matrix, including:

- A sortable and searchable excel file.
- One-stop-shop Rates Matrix that contains rates, standards, billing rules, and other needed information in a single document.

The DRAFT SUD Reimbursement Rates for FY 2023-2024 and DRAFT Rates Matrix, contains more detailed information regarding the rate.
