TCPX QUICK REFERENCE AND TROUBLESHOOTING GUIDE

TCPX – INTRODUCTION

TCPX (Treatment, Court, Probation eXchange) provides a "real-time" connectivity between contracted SUD treatment agencies, the Client Engagement Navigation System (CENS), Probation, and Department of Public Health, Substance Abuse Prevention and Control. Given that accurate records must be maintained to permit patient access to needed services, all treatment providers are required to accurately enter all patients' data into the TCPX system daily.

Contracted Substance Use Disorder (SUD<u>) treatment agencies accepting referrals from the</u> <u>Probation Department AB109 are required to utilize the TCPX System</u>, which is a web-based data system application designed to support the operational and administrative requirements of Probation Supervision.

TCPX System may be accessed from a web browser:

- Website Direct Access (Token required)
- Public Health Web Portal (Tokenless)

TCPX – STIPULATIONS AND CONDITIONS OF USE

TCPX and DPH-SAPC Requirements:

- According to DPH-SAPC's Treatment Service data requirements, providers shall enter patient and service activities in TCPX electronic data collection system.
- SAPC contracted SUD treatment providers <u>accepting referrals from the Probation</u> <u>Department</u> are required to utilize the **TCPX System**, data system designed to support the operational and administrative requirements of Probation Supervision.
- Given that accurate records must be maintained to permit patient access to needed services, all treatment providers are required to accurately enter all patients' data into the TCPX system daily.

SAGE - LOGON (via PUBLIC HEALTH WEB PORTAL)

TCPX via SAGE is accessed by opening your **Internet Explorer** browser from your computer. Enter the following URL/Link:

https://DPH.ERA.LACOUNTY.GOV/DPH/SAPC

In your Internet Explorer 🙆 URL address line and hit Enter.

LOGGING ONTO TCPX WEBSITE (via SAPC Web APPLICATION)

The first screen you encounter is the Department of Public Health screen (shown below). This screen and access to it is maintained by Department of Public Health Substance Abuse Prevention and Control (**DPH-SAPC**). If you do not have a "C" number issued by SAPC and assigned to TCPX, you will not be able to logon to TCPX system.

To access TCPX system:

- A "C" number is required for <u>vendors and contractors</u>. "C" number is an identification number starting with a letter "C" and followed by 6-numbers. This identification is assigned to you by SAPC.
- An "E" number is required for <u>LA County Employees</u>. "E" number is an identification number starting with a letter "E" and followed by 6-numbers. This identification is assigned to you by Human Resources or your Department.

Enter your "C" or "E" number in the Hosted Username field and your password in the Hosted Password field; press Sign In.

- 4. Enter your "C" or "E" number in the **Logon ID** field, for example (**C**001234)
- 5. Please Note:
 - a. A "C" number is required for <u>vendors and contractors</u>. "C" number is an identification number starting with a letter "C" and followed by 6-numbers. This identification is assigned to you by SAPC.
 - b. An "E" number is required for <u>Los Angeles County (LAC) Employees</u>. "E" number is an identification number starting with a letter "E" and followed by 6-numbers. This identification is assigned to you by Human Resources or your Department.
- 6. Enter your four-digit or five-digit PIN number followed by the SECURID number shown on your token's screen, in the Passcode field.
 - a. Note that the number in the window changes every 30 seconds.
 - b. If you do not have PIN number, you can create one. See instructions in this document on "SETTING A PIN ID FOR YOUR SECURID TOKEN"
- 7. IF YOU EXPERIENCE ANY ERROR MESSAGES when trying to logon, after two attempts, click on the **Reset** button to re-create your PIN. If you continue to have problems, call the Internal Services Division (ISD) Customer Support Line at (562)403-3305 and request to reset your PIN number. WAIT 10 MINUTES and follow the logon steps outlined above
- 8. Press Enter or click on Log In button
- 9. The TCPX logon screen will ask you for **User ID** and **Password**. Enter your "C" or "E" number in the **UserID** field and your password in the **Password** field; press Login.

HOW TO OBTAIN A SECURID TOKEN

To access TCPX you will need to obtain a SECURID TOKEN. A SECURID TOKEN is requested from LA County Internal Services Division (ISD) by completing the **COUNTY OF LOS ANGELES DOWNEY DATA CENTER REGISTERATION** form.

This form can be obtained by contacting TCPX or LACISD. Complete this form by filling in the required information in the **PROFILE INFORMATION** -- section (first page of the form - see sample form below). Please make sure to <u>put your "C" number on in box (3)</u>.

SETTING A PIN # FOR YOUR SECURID TOKEN

Once you have received your token, you must select and set up a 4-digit or 5-digit PIN, just once. This PIN # is used in addition with your token-generated number to logon on to TCPX.

Save your PIN number in a safe place, as you are the only person who should know your PIN number.

Here are the steps to setup your PIN number for the first time:

- Have your token with you before calling
- Select a 4-digit or 5-digit PIN that you will remember as your PIN number
- Call ISD Help Desk at (562) 403-3305
- Once prompted by the automated response system, select either:
 - Employee if you have an "E" #
 - o Contractor if you have a "C" #
- Select "All Other Issues" (number 4)
- Once you are connected to a Help Desk representative, let them know you are setting up your PIN number for the first time

- Help Desk representative may ask you to call out two (2) sets of rotating token numbers to sync your token with the verification system
- Help Desk representative will ask you to logon with your Logon ID (E # or your C#) and enter the Passcode (token's rotating number) into TCPX website verification screen:

- Press Enter
- Enter the PIN number you selected. Confirm the PIN number by entering it again, press Enter
- Now your PIN number is set
- Remember and protect your PIN number, as you are the only person who should know this number!

RULES REGARDING THE SECURID TOKEN

- The person to whom the token has been issued, is responsible for making sure that the token is kept in a secure place at all times. In the event the token is lost or stolen, it must be reported to the TCPX support team or ISD Help Desk at (562)940-3305 within 72 hours. Any token reported lost or stolen will be inactivated
- Any one person may not have more than one active token at any given time. Supervisors, managers, or administrative staff should not request tokens unless they are responsible for data entry functions
- DPH-SAPC pays the costs associated with the tokens

- Tokens issued to staff that leave the employment of the Treatment Provider can be re-assigned to other Provider staff, at the Treatment Provider Director's request
- Tokens generally expire after 3 years; the expiration date is engraved on the back of each token
