Medi-Cal Peer Support Specialist Certification Program



Qualifications for Medi-Cal Peer Support Specialists

- At least 18 years of age and have a high school diploma or GED
- Self-identify as an individual with lived experience
- Be willing to share their experience as a person with lived experience
- Agree to adhere to the DHCS Code of Ethics for Medi-Cal Peer Support Specialists in California
- Complete an 80-hour training for initial certification or 20 hours of continuing education for certification through grandparenting
- Pass a State approved Medi-Cal Peer Support Specialist Exam

Scholarships for certification through the grandparenting process

- A total of 5,000 scholarships will be distributed, 2,500 for peers under the grandparenting process and 2,500 for peers seeking initial certification.
- In order to be considered for a scholarship, individuals must be recommended by SAPC or DMH
 - If you are interested in recommending yourself or someone else for a scholarship, please notify SAPC by sending an email to <u>SAPC_ASOC@ph.lacounty.gov</u> with the following information:
 - 1. Recommended peer candidate's full name;
 - 2. Provider agency name (place of employment for recommended peer candidate);
 - 3. Recommended peer candidate's current position;
 - 4. Recommended peer candidate's email and/or phone number; and
 - 5. Name of recommended peer candidate's direct supervisor



Scholarship Rollout

May 2, 2022 – July 31, 2022 or until scholarships have been depleted

- Applicants seeking certification under the grandparenting process must be employed as a Peer as of January 1, 2022, and shall meet the work experience, training requirements, and all other requirements under the grandparenting process.
- Scholarship under the grandparenting process covers application and exam costs.

July 1, 2022 – September 30, 2022

- Applicants seeking initial certification, not under the grandparenting process shall meet training and all other requirements.
- Scholarship covers application, training, and exam costs.

PAC New Member Selection (cont.)

- 50% of PAC members (Group A) will term out 6/30/22
- SAPC will be releasing the PAC Application and associated Memo by May 20, 2022
- Applications will be due by June 10, 2022
- SAPC staff will confirm receipt of all applications via email
- The PAC Selection Committee will be led by the PAC Co-Char and be made up of 4 PAC members and 5 SAPC Staff
- The PAC Selection Committee Members will be chosen by the Co-Chair from members whose term will not be ending



PAC New Member Selection (cont.)

- PAC CO-Chair will be reaching out in the next couple weeks to identify Selection Committee Members
- SAPC staff will review all applications received to ensure candidates meet established criteria (refer to PAC bylaws) and advance each completed application to the PAC Selection Committee for review
- Each completed application will be considered and discussed by the PAC Selection Committee
- Selection Committee Members will then cast a vote to decide on incoming members
- All applicants will be informed of the Selection Committee's final decision by week of July 4, 2022.

Recovery Bridge Housing Questions

- It can be very difficult to get someone housed within 180 days. If the client is discharged from RBH, can they return for more time if needed? Is there a limit of 180 days total per client or is it based on medical necessity criteria?
- Any success with placing couples in RBH?
- Due to RBH being abstinence based is the best course of action to require the patient accept a higher level of care if they continue relapse and use while in RBH?
- Success in navigating RBH and finding beds for patients
- What staffing levels do the most RBH's employ?
- Words of wisdom concerning client meals?
