Welcome	Dr. Gary Tsai, MD, Bureau Director, Los Angeles County, Department of Public Health (DPH), Substance Abuse Prevention and Control Bureau (SAPC)

Approval of Meeting Minutes	 Armen Ter-Barsegyan (DPH) Armen Ter-Barsegyan (DPH) provided PAC members with the meeting minutes from April 9, 2024. A motion to approve the meeting minutes with no changes was advanced by Liana Sanchez (Los Angeles Centers for Alcohol and Drug Abuse) and seconded by Christina Gonzales (Principles, Inc.). 	
Building Communities of Belonging	 Maricela Gray (House of Hope) and Baldomero "Junie" Gonzalez (Cri-Help) Baldomero "Junie" Gonzalez (Cri-Help) shared that during the last Building Communities of Belonging meeting, the workgroup focused on finalizing recommendations for capacity building in the upcoming fiscal year. These recommendations pertain to language access and establishing support for a bilingual bonus.

2024 PAC Membership / PAC Awards	 Armen Ter-Barsegyan (DPH) Armen Ter-Barsegyan (DPH) stated that the 2024 – 2026 PAC Membership application period has closed, and the selection committee is currently reviewing the applications. Additionally, the PAC award nomination forms will be released soon, and the winners will be announced on November 5, 2024, at the All-Treatment Providers Meeting. 	
FY 2024-25 SAPC Rates	 William Taetzsch (Didi Hirsch) William Taetzsch (Didi Hirsch) inquired whether there were any updates to the provider network's 2024-2025 SAPC rates. Francisco Reyes (DPH) stated that the FY 2024 – 2025 rates are being finalized and incorporated into our systems. It was added that Finance anticipates having the rates matrix updated later this week, ready to be released to the provider network soon after that. The delay involved adjusting to the State's recently modified rates related to outpatient services. Dr. Gary Tsai (DPH) stated that the care coordination, medication services, peer support services, and recovery services will be billable on top of residential rates for at least the upcoming year. It is crucial that residential agencies bill for all services they provide, particularly those not yet bundled, to ensure these services are billed in addition to any general service charges. This approach serves two main purposes: (1) to maximize current reimbursement, and (2) to ensure that all billable fees are included when calculating future bundled service provision rates. There was considerable discussion about this issue due to its impact on the State's calculation of future, more comprehensive service bundling rates. It was emphasized that State agencies typically set bundled rates based on past submissions of services and costs. If services have not been documented previously, future rates will not account for those fees. Providers were also reminded to report on capacity building and incentives by the end of the third quarter, instead of the end-of-year deadline that was previously in place. 	
CA Projected Budget	 William Taetzsch, Didi Hirsch William Taetzsch (Didi Hirsch) raised the question of how the projected State budget might impact SAPC funding. Dr. Gary Tsai (DPH) stated that one related feature which SAPC is monitoring a proposed reduction in funding for the Behavioral Health Bridge Housing (BHBH) program. Although SAPC still plans to invest in BHBH, it is uncertain where the budget will settle. Governor proposed 	Note: this was a discussion of the CA budget proposal. 	cuts to CalWORKS and Behavioral Health Continuing Infrastructure Program. The projection for realignment is a 2% increase, which includes flexible funding for behavioral health.	https://ebudget.ca.g ov/ for the enacted CA budget.
Capacity Building Initiative	 Dr. Gary Tsai (DPH) Dr. Gary Tsai (DPH) discussed two bills, AB 2479 and AB 2893, related to recovery housing. These bills would allow for a proportion of housing funds to be used for recovery-oriented housing. Between the two bills, up to 25% of housing funds could be used for recovery-oriented housing. AB2802 would also establish State cartification of scher living facilities. 	
Recovery Housing Bills (AB 2479 & AB 2893)	 oriented housing. AB2893 would also establish State certification of sober living facilities. Dr. Gary Tsai (DPH) Dr. Gary Tsai (DPH) discussed two Recovery Housing Bills, noting that they are similar. These bills would open funding for investments in recovery-oriented housing up to a certain proportion. Specifically, 25% of the housing funding could be used for recovery-oriented housing. One key difference between the two bills is that AB2893 would require state-certified sober living facilities. 	
CA Proposition 1	 Dr. Gary Tsai (DPH) Dr. Gary Tsai (DPH) discussed changes stemming from California Proposition 1, particularly the Behavioral Health Services Act (BHSA) allows for funds to be used on SUD. Prop 1 will establish a BHSA Commission, which can decide on policy, review county performance, and how funds should be used. A Behavioral Health Outcomes Accountability and Transparency Report will be required for all behavioral health activities. SAPC wants to make sure BHSA includes SUD investments and SUD is represented on committees and reports. We want to make sure BHSA funding supports recovery housing, prevention, and BHCIP. Regarding Behavioral Health Administrative Integration, LA County has a stronger SUD system, because we have a separate administration from mental health. CEO Budget hired a consultant to review integration between SUD and mental health administration. PAC members are interested in hearing about how the BHSA Commission would be appointed and wanted to make sure there would be SUD representation. 	
Certified Medi-Cal Peer Support Specialists (CMPSS) Updates	 Zena Yusuf (DPH) Zena Yusuf (DPH) provided an update on the Certified Medi-Cal Peer Support Specialists program. She announced that the scholarship cycle is reopening for the second time. The application and approval processes have been simplified, and scholarships will be awarded on a first-come, first-served basis, provided candidates meet the requirements to become a Peer Support Specialist. Details on accessing the scholarship can be found in the scholarship
