PURPOSE

- Reach historically difficult to serve populations
- Increase patient participation and retention in treatment services
- Enhance family engagement, particularly for youth



COUNTY OF LOS ANGELES Public Health

ELIGIBILITY

- Opportunity open to any treatment provider with a current and active FBS workplan
- Targeting participation from at least 5-7 provider agencies
- Eligible levels of care and treatment services



DOCUMENTATION REQUIREMENTS

- Patient signature or provider-documented verbal consent
 - Youth patients must provide consent from parent/guardian.
- Clinical Documentation
 - Selection of FBS as service delivery method in Sage
 - Provide justification for in-home FBS service provision
 - Note service delivery location
 - Note confidentiality practices, in alignment with requirements
- Claims
 - Include the appropriate place of service code within claims (12)

Peer Certification Program Update

- Peer Certification Specialist Program is slated to start July 2022
- BHIN 21-041 set standards for Peer Certification, but some flexibilities exist
- California Mental Health Service Authority (CalMHSA) is representing California counties in the implementation of statewide plan
 - CalMHSA will submit Peer Certification plans to DHCS by November 19, 2021
 - CalMHSA held 12 listening sessions throughout October to get feedback on flexibilities
 - November-December 2021: CalMHSA is planning to report back on listening session notes and start development of exam questions



Current Use of Peer Specialists

- SAPC is interested in understanding how peer specialists are currently being utilized within the network now in order to inform program and policy development
 - How are providers using peers right now without reimbursement?
 - What funding sources are used to support peer specialist activities currently?
