# **Contracted Programs**

- Prevention Standalones: Agencies contracted with SAPC to provide only Prevention Services
- Other agencies provide Prevention Services in addition to DMC and/or DUI services



# **Community Mobilization and Referrals**

Your continued interaction and collaboration with the community is how we:

- Educate the community
- Provide valuable resources and referrals



# **Contracts Management's Role**

## Augmentations

- Increased efforts may require additional staff or supplies
- Agencies can request funding increases via a Contract Amendment Form
- Prevention Staff and CPAs may contact you for additional information to evaluate augmentation requests.

## **Contract Updates**

- Report all changes (e.g., relocation, site additions, phone changes) to your assigned CPA
- Final approval from Contracts is required before implementing services

## **Provider Invoice Automation System (PIAS)**

- Implemented in July 2023 for billing; agencies were required to register and use it
- Relaunched in January 2024



# **Compliance Management's Role**

## Auditing and Oversight

- Ensure billing accuracy, deliverable completion, and compliance through audits
- Conduct site visits and annual audits, addressing any deficiencies

### Support and Collaboration

- Confirm staffing for prevention activities
- Collaborate with Prevention Specialists to provide technical assistance
- Serve as liaison for Contracts and Finance

# Los Angeles County Office of Violence Prevention (OVP)



### Social Determinants of Health (Root Causes)

OVP strengthens collaboration, capacity and partnerships to prevent multiple forms of violence and promote healing across communities in LA County.

Established by the Board of Supervisors in February 2019 in the Department of Public Health.

**Governance Structure:** County Leadership Committee & Community Partnership Council guide the work of the office and implementation of the strategic plan.



#### **Public Health Approach to Violence Prevention**

Is **comprehensive**: incudes strategies at multiple levels Reduces Risk Factors and Increases Protective Factors Focuses on **population health**, not just individuals

Addresses the context [socio-ecological model] Is Data-Driven: to understand the circumstances of violence and evaluate strategies

Facilitates Multi-Sector **Collaboration** and Coordination

**Engages those most impacted**, survivors or perpetrators, in developing and implementing the solution

## **New Crisis Response Initiatives**



#### Crisis Response – Care and Response Team (CART) South LA Pilot

- Rapid, in-home and in-community connection to the individuals and families most directly affected.
- Linkages to services for ongoing/longer term social and behavioral health needs.
- Culturally and linguistically inclusive services and peer staff.

#### **Family Assistance Program**

 Peer healing supports and burial cost assistance to families who lost a loved one due to Deputy fatal use of force or death in custody



## **New Suicide Prevention Pilot**

#### Youth Suicide Prevention Reporting and Crisis Response Pilot (CDPH Grant – 2 years)

- Technical assistance to strengthen reporting and crisis response
- Local advisory body
- Funding for CBOs and county partners





# **New Gender Based Violence Initiatives**

#### **Sexual Assault Council**

- Convene council to lead a coordinated response
- Funding for prevention programs and communications

#### **Gender Based Violence Prevention\***

- Coordinate GBV work throughout the county through collaboration, policy work, research and evaluation
- Teen Healthy Relationships Curriculum for high schools
- Community programs for LGBTQ+ youth, men and boys, and economic empowerment for young women
- Flexible hardship funding for service providers and survivors

#### American Rescue Plan Act (ARPA) Funding

- Informed by existing TPI violence intervention and prevention efforts and CAP input
- Intended to expand and deepen violence prevention work launched through TPI
- **\$25 Million** allocated to Public Health/OVP to fund community-based organizations (July 2023 May 2025) to support:
  - Street Outreach, Hospital Violence Intervention
  - Peer-to-Peer Learning Academy
  - Youth Healing, Mentorship and Leadership Programs
  - Crisis Response and Community Healing Programs
  - School Safety Transformation Grants
  - Trauma-Informed Care

# **Gun Safety**



#### LA County Platform to Address Gun Violence

# Developed Summer 2022 with county and community partners. A total of 40 strategies w/ 4 Immediate Priorities:

- 1. Continue to advocate for **robust gun safety legislation** locally and nationally, including the reinstatement of the federal ban on assault weapons and large capacity magazines.
- **2.** Increase violence prevention, intervention and healing programs and events to promote social connectedness and a culture of peace.
- 3. Improve enforcement of Domestic Violence Restraining Orders and Gun Violence Restraining Orders, in partnership with courts, community and law enforcement and ensure these are culturally appropriate
- 4. Increase access to comprehensive culturally relevant physical and mental health services for school-aged children; and invest in a comprehensive school safety initiative.


- Public can order 1-2 free gun safety locks and get free educational materials at: <u>LACountyGunSafety.org</u>
- Public can obtain gun safety locks and get free educational materials at 11 county sites:
  - 6 LA County DHS Medical Centers
  - 6 LA County Tool Lending Libraries
- To date, OVP has distributed
  18,960 free gun locks since launch in April 2024!

## Gun Violence Restraining Orders (GVROs) Education and Outreach Campaign

- Gun Violence Restraining Orders can be helpful if a person who has access to guns is in crisis and showing signs that they might hurt themselves or others.
- GVROs can stop someone from having, owning, or buying firearms (guns), firearm parts, ammunition, or magazines.
- These can be obtained by police, family members and partners, housemates, employers, co-workers, and school officials.
- A GVRO removes guns and/or ammunition for 21 days and up to 5 years from individuals who are at risk of harming themselves or others.

#### **Trauma Prevention Initiative (TPI) Overview**

A community-based approach to public safety that is comprehensive, place-based, invests in peer intervention strategies and community leadership, and adapted to the unique needs of communities

#### INTERVENTION: Hospital Violence Intervention Program (HVIP)

CBOs partner with trauma hospitals to engage victims of violence

- 24/7 response bedside in the hospital
- Case management services
  post hospital discharge
- Referrals to needed services: victim benefits, counseling, employment, housing, substance use treatment, others



2017: 1 hospital

2022: 4 hospitals



#### INTERVENTION: Street Outreach & Community Violence Intervention (SOCVI)

CBOs employ credible messengers with lived experience to de-escalate community tensions and promote peace

- Respond to violent incidents to reduce retaliatory violence and promote peace
- Peace maintenance and rumor control
- Safe passages to parks and schools
- Case management for violence impacted community members including peer mentoring and service referrals
- Community peace activation events



2018: 4 communities 2022: 9 communities



#### **TPI Parks Safe Passage**

- TPI Street Outreach agencies partner with LA County Department of Parks and Recreation to provide safe passage and proactive peacekeeping services at Parks After Dark (PAD) and Our SPOT (Social Places and Opportunities for Teens).
- PAD and Our SPOT transforms parks into community hubs providing a foundation for other agencies to leverage for prevention and intervention strategies





## CAPACITY BUILDING: Training and Technical Assistance (TTA)

- Cohort-based, up to 14 agencies in TPI communities and other priority areas, funded through Probation JJCPA
  - 1:1 TTA, Operations and organizational development
  - Peer learning meetings
  - Mini grants (\$50k)
- Participating in Countywide Capacity Building
  Workgroup to coordinate and advance systems change



#### **Community Action for Peace Coalitions**

OVP/CBO lead co-design a safety strategy with community stakeholders, promote collaboration and community pride

- Build and support a coalition of diverse stakeholders
- Support local leadership and decision making
- Elevate needs and concerns with city and county leadership
- Identify priorities for community to promote peace and well-being
- Provide mini grants to implement community identified strategies to advance community well-being and healing

- **Regional approach** across cities and unincorporated communities and "public safety" agencies
- Connecting and aligning county strategies in hardest hit communities to support community-driven solutions
- Support systems to address vicarious trauma for <u>all</u> responders
- Capacity building for grassroots organizations and equitable contracting
- Training to support culture shift within systems for survivor and healing centered work
- Career pathways, diverse workforce, and professionalization
- Community coalitions (CAPs) in unincorporated communities to advance community-driven public safety solutions.
